

# GOH CHOK TONG ENABLE AWARDS (UBS Promise)



## NOMINATION FORM

Emeritus Senior Minister (ESM) Goh Chok Tong first mooted the idea of awards to recognise the achievements of persons with disabilities at Tote Board's 30<sup>th</sup> Anniversary celebrations in February 2018. In response, Mediacorp and SG Enable launched the Goh Chok Tong (GCT) Enable Awards, supported by Mediacorp Enable Fund, in January 2019. The Awards aim to recognise the achievements of persons with disabilities, and motivate those with promise and potential to go the distance.

### AWARD DETAILS

1. Objective: To encourage and support persons with disabilities who have showed promise in their own fields towards greater excellence.

2. Eligibility Criteria:

- Nominees must be Singapore citizens or Permanent Residents 12 years of age and older, with a permanent disability.
- Nominees must demonstrate one or more of the following criteria:
  - a) Be of high integrity and moral character
  - b) Exhibit perseverance and courage
  - c) Shown evidence of traits, inherent skills or abilities, or aptitude for honing a particular skill of any field
  - d) Shown good and consistent performance in their own field of expertise and/or the community

### APPLICATION INSTRUCTIONS

1. All sections of the nomination form must be completed

2. Submit the completed nomination form, with the following supporting documents by e-submission:

- a) A copy of NRIC
- b) Proof of permanent disability
- c) Education and Skills Certifications
- d) Testimonial from a referee that acknowledges nominee's character and promise shown in a field of expertise
