

# GOH CHOK TONG ENABLE AWARDS

## FREQUENTLY ASKED QUESTIONS

### General Questions

**1 Can an individual apply for the award(s)?**

No, candidature for the award(s) is strictly by nomination.

**2 Who may make a nomination?**

Nomination(s) can be made by an individuals or organisations. Individuals exclude immediate family members. Organisations refer to non-profit, public and private corporates. However, only Institutions of Public Character or Government Educational Institutions will qualify for the monetary award under the Goh Chok Tong Enable Awards (UBS Achievement).

**3 How can nominations be made?**

Nominator to download form from website, complete and email the completed editable PDF form to [GCTEA@mediacorpenablefund.sg](mailto:GCTEA@mediacorpenablefund.sg).

**4 Can an individual be nominated by different nominators for the same award?**

Yes, he/she can be nominated by different nominators for the same award. Should more than one submission be submitted for a nominee, prize money will be divided equally amongst deserving organisations that fulfils the following criteria:

- a. Nominating organisation must have made a compelling, relevant submission; complete with examples and supporting documents that demonstrates nominee fulfils eligibility criteria
- b. Nominating organisation must be either an Institution of Public Character or Government Educational institution

**5 Can an individual be nominated for both awards?**

Yes, he/she can be nominated for both awards but the nominations must not be from the same nominator.

**6 Must the nominator inform his/her nominee prior to nomination?**

Yes, the nominee must consent to nominator's nomination.

**7 Can an individual receive an award more than once?**

An individual is only allowed to receive an award once in his/her lifetime for each award category and not both at the same time.

### Questions on Eligibility Criteria

**8 Can nominee be non-Singaporean nor Permanent Resident but awaiting approval of their Permanent Residency status at the point of nomination?**

No, nominee must either be a Singapore citizen or Permanent Resident at the point of nomination.

### Questions on Supporting Documents

**9 What type of supporting document is required to certify that nominee has a permanent disability?**

Acceptable documentations are:

- A copy of his/her disability assessment report endorsed by a registered healthcare professional
- A copy of his/her membership card of a disability organisation
- A copy of his/her Public Transport Concession Scheme for Persons with Disabilities card

### Questions on Nomination Status / Outcome

**10 How will the nominator be informed of status by award administrator?**

Nominees will receive an acknowledgement of receipt of nomination by email within 3 working days. If you do not receive any acknowledgement email by then, please email [GCTEA@mediacorpunablefund.sg](mailto:GCTEA@mediacorpunablefund.sg) to enquire.

### Evaluation

**11 What is the evaluation process?**

Nominees may be shortlisted for an interview or tea session with the evaluation panel. Thereafter, awardees would be informed by email.

**12 Must nominees attend the interview or tea session with the evaluation panel?**

Nominees are encouraged to attend but in cases where they are unable to, alternative means of meeting the nominee such as by video conference will be arranged, as appropriate.

**13 Who makes up the evaluation panel?**

The evaluation panel consists of judges whom are representatives of the Mediacorp Enable Fund Office and Sponsoring Organisations of the Goh Chok Tong Enable Awards.
